MEMBERSHIP CATEGORIES IN ACCORDANCE TO CLAUSE 5.1 OF THE MAESCO CONSTITUTION
i. Ordinary Member
Open to Companies incorporated in Malaysia and owned at least 51% by Malaysian Citizens and are directly involved in the Energy Service Industry (ESCO). There are 3 sub categories of Ordinary Members as follows:
<b>Class A</b> ESCO Energy Efficiency Services (EE) and/or Renewable Energy Services (RE) A Company that offers EE and/or RE services and are able to undertake or offer Energy Performance Contracting (EPC) model.
<b>Class B</b> A Company that offers EE and/or RE services but not by way of EPC model.
<b>Class C</b> Companies that were incorporated in Malaysia within less than three (3) years from the date of application and is directly involved in the Energy Service Industry.
ii. Associate Member
Open to Companies incorporated in Malaysia and are directly involved in specific areas of Energy Services Industry such as Energy Efficient Equipment/Components, Training in relation to Energy Management, Financing etc.
An Associate member is not permitted to vote nor hold position in the Association.
iii. International Member
Open to: -Companies incorporated in Malaysia, owned more than 51% by foreign citizens and are involved directly in the Energy Service Industry -Companies that are not incorporated in Malaysia and are directly involved in the Energy Service Industry (eg: Foreign ESCO)
An International Member is not permitted to vote or hold positions in the Association.
