



## TERMS AND CONDITIONS FOR CERTIFIED MAESCO COURSES REGISTRATION

### 1. Payment Options

Participants can pay for the Certified MAESCO courses through one of the following methods:

- **SBL-KHAS Scheme:** Participants claiming funds under the SBL-KHAS scheme from the Human Resources Development Corporation (HRDC) MUST provide their SBL Khas Grant ID. The SBL Khas Grant ID MUST be submitted **at least two weeks before the course date.**
- **Bank Transfer:** All course fees MUST be transferred to:

Payment receipts **MUST** be submitted at least **two weeks** before the course start date. Failure to provide proof of payment within the specified timeframe may result in forfeiture of the reserved slot.

### 2. Cancellation and Refund

- **Advance Notice:** Cancellations MUST be communicated to MAESCO at least fourteen (14) working days before the course begins for a full refund.
- **Late Cancellation Fee:** Cancellations made less than fourteen (14) working days before the course start will incur a fee of 20% of the total course fee to compensate for administrative costs and potential revenue loss.
- **No-Show:**
  - **SBL-KHAS Scheme Participants:** Participants who register under the SBL-KHAS scheme and fail to attend without prior notification will have their organizations held liable to pay the full course fee.
  - **Direct Bank Transfer Participants:** Participants who pay via direct bank transfer and fail to attend without providing a concrete, verifiable reason will not be eligible for any refund.
- **Course Changes and Cancellations:** MAESCO reserves the right to alter the course schedule, content, venue, or to cancel the course entirely due to unforeseen circumstances. Affected participants will be notified promptly and refunded in full for cancellations initiated by MAESCO.
